We all enjoy living in this community because of the many outdoor activities. We like to hunt, fish, and hike. We embrace the beautiful area that we have chosen to live.

Arizona state law requires a motor vehicle to be registered and insured to be operated on any roadway. Any vehicle being operated without valid registration, insurance, and a properly licensed driver is subject to being towed and impounded for 30 days.

Four-wheeler traffic has become increasingly problematic. A recent problem up the San

Francisco River resulted in some private property being closed due to certain individuals causing damage to the land.

The Sheriff's Office has received complaints from all areas of Greenlee County concerning the use of all-terrain vehicles. Due to the few irresponsible drivers the responsible operators, land owners, and the community have been affected by the consequences. Most of the complaints could be avoided by being a good neighbor. Treat the land the way you would if it were yours.

- Drive your vehicle as if your children might be walking down the road.
- Pick up your trash and carry it home with you.
- Close any gate you open.
- Do not take down a fence to access an area.
- If you see anyone not following the basic rules, report them to law enforcement.

It's time that the community gets involved. We encourage you to be a good neighbor.

## Outdoor Marijuana Cultivation



- Outdoor marijuana cultivation has been on the up rise in Arizona, California, and Oregon in the past few years.
- Most outdoor cultivation sites are organized by Mexican Marijuana Cartels that pose different dangers to the public.
- Reporting of active or dormant cultivation sites from the public is extremely important for the effective detection, investigation, and eradication of marijuana cultivation sites.
- What to look for?
  - Marijuana plants
  - Black drip line tubing
  - Fertilizer bags
  - Hidden camp sites
  - Cultivated land
  - Small springs or seeps
  - Heavily used foot trails in remote areas
  - Suspicious persons in the outdoors
- Report all suspicious activity.
- Your information is vital to law enforcement.
- You will remain anonymous!

## New at Greenlee County Sheriff's Office

The Greenlee County Jail used to contract out for the meals provided to the inmates. Twenty years ago this was acceptable and probably the most cost effective for the time. Due to the increase in the number of inmates being housed it has become more cost effective and better for the overall security of the jail to prepare meals in house. We have installed a kitchen and now purchase food at cost. We have utilized inmate labor to reduce cost. We are now preparing meals for a savings of about \$2,400.00 per year. We anticipate that the savings will increase while the quality of food continues to meet the federal and state standards.

The Greenlee County Jail continues to house Graham County Inmates. To this date Graham County has been billed over \$386,000.

We have recently found some issues in the structure of our 30 year old jail. We have addressed these issues by reinforcing these areas with metal plates. Jail Commander Deborah Macias has been instrumental in increasing training and updating policies for the jail staff. We have installed new cameras and recording systems to record the vital areas of the jail. This recording system protects the staff and the community from false allegations, law suits, and ensures the staff is

completing their assigned tasks.

The inmate work program continues to serve the needs of the community. This program is operated under the direction of Sheriff Tucker, Jail Commander Macias, and supervised by Detention Officer Ronnie Manuz. The inmates continue to complete the labor needed to successfully operate the **Counties Gleaning Program**. This program provides excess harvested food to those in need. The Inmates clean trash and weeds from schools, streets, yards, fields, and cemeteries. We have assisted the towns of Duncan and Clifton to complete projects. The Inmate is rewarded only by the sense of accomplishment and the feeling of giving back. We have saved money by performing labor for which the county would normally have to pay. All of the Inmates involved in the work program are serving short sentences and will quickly return to the community. They gain a sense of pride in the community in which they live because of the labor they have provided.

The Greenlee County Jail in conjunction with the Greenlee County Probation Department continues to provide a substance abuse program to all inmates. This program includes:

- Needs assessment.
- Treatment action plans.
- Required counseling.
- The opportunity for the inmate to understand addiction.
- Long term continuous treatment.

This long term treatment has proven to be effective, especially with

methamphetamine addiction.

According to Gila Health Care Staff, Greenlee County has seen a reduction in the number of persons arriving for emergency medical treatment for methamphetamine related issues. According to the Probation Department we have seen a reduction in the amount of probationers testing positive for methamphetamine. We at the Sheriff's Office have seen a reduction in the number of methamphetamine related arrests. We believe that this success is a result of:

- The community not tolerating methamphetamine use.
- Increased enforcement action by Greenlee County Narcotics Task Force.
- Education and enforcement by Greenlee County Sheriff's Office School Resource Officer Rudy Pedregon.
- The Greenlee County Meth Coalition education, treatment, and prevention program.

Every one of these programs is important to maintain and improve these results. The most important of these is the community not tolerating the problem.
